## PARENT / LEGAL GUARDIAN CODE OF CONDUCT AGREEMENT - 2023

As a parent / legal guardian of a child enrolled at Nkhwazi Primary School, I will abide by and follow the rules and guidelines stipulated below:

- 1. I will promote the emotional and physical well-being of the children and staff at Nkhwazi Primary School.
- 2. I will remember that my child comes to Nkhwazi Primary School to be educated academically and morally.
- **3.** I will uphold good parenthood through my actions, by demonstrating positive support for all children and staff at Nkhwazi Primary School.
- **4.** I will provide support for teachers and other officials working with the children to provide a positive experience for all.
- **5.** I will encourage my child to treat all children, teachers, officials and parents with respect regardless of race, creed, colour, sex or ability.
- **6.** I will treat all children, teachers, support staff and Nkhwazi parents with dignity and in language, attitude, behaviour, and mannerisms.
- 7. I will respect the property and equipment used at Nkhwazi Primary School, both home and away.
- 8. I will not use any abusive or threatening language to any member of staff or children of Nkhwazi Primary School.
- **9.** In a case of a dispute I will not talk to the child without the express permission of the Head of School, the Deputy Head or the parent.
- 10. I will not touch, beat or use offensive language to any child or staff of Nkhwazi Primary School.
- **11.** I will not put defamatory, offensive or derogatory comments regarding the school as any of the pupils/parents/staffs/board members of the school on Facebook or other sites.

## **CONDUCT SUBJECT TO DISCIPLINE**

Examples of words or actions which will constitute a violation of the Code include, but are not limited to the following:

- 1. Making physical contact with any child or staff at Nkhwazi Primary School.
- 2. Taunting or threatening any child or staff of Nkhwazi Primary School.
- **3.** Going into the classroom or office threatening a child or member of staff.
- **4.** Using profane and / or vulgar language or mannerisms.
- 5. Defacing or damaging property belonging to a child, member of staff or Nkhwazi Primary School.
- **6.** Being involved in any activity that would warrant the summoning of law enforcement officials.

- **8.** Any other conduct that is not in compliance with the Nkhwazi Primary School rules and regulations.
